

Privacy Policy of Use of the “Dreams Without Borders” Contest

1. General Provisions

1.1. This Privacy Policy (hereinafter — the “Policy”) explains what personal data is collected and processed when using the website <https://eggifest.com>, participating in the “Dreams Without Borders” contest, and making voluntary donations in support of the project.

1.2. The Organizer (hereinafter — “we,” “Eggifest Ltd”) acts as the data controller within the meaning of Regulation (EU) 2016/679 (GDPR).

1.3. The contest is intended for children aged **6 to 12 years**, who may participate **only with verified consent** from their parents or legal guardians.

2. Categories of Data Collected

2.1. Data about the child (contest participant)

- First name, age, country, and city of residence;
- Photos, videos, texts, and other elements of the contest entry;
- Avatar or nickname (if used).

2.2. Data about the parent or legal guardian

- First and last name;
- Contact details (e-mail, phone number);
- Confirmation of consent for the child’s participation and data processing;
- Payment details (if the paid capsule storage service is used).

2.3. Technical data

- IP address, country, language, device type, browser;
- Cookies and log files;
- Voting-related data (date, IP, device, session).

2.4. Donor data

When making donations through the Stripe payment system, we receive and process:

- First name, last name, and e-mail;
- Payment amount, currency, and date;
- Payer’s country;
- Transaction ID.

Important: Card details (number, expiry date, CVV) are processed **only** by **Stripe Payments Europe Ltd** in accordance with their Privacy Policy and the PCI DSS security standard. We do not receive or store card details.

3. Purposes of Data Processing

We process personal data for the following purposes:

- Registration and verification of contest participants;
- Submission, publication, and moderation of contest entries;

- Conducting voting and determining winners;
- Communication with parents and participants;
- Delivery of prizes and certificates;
- Processing donations via Stripe;
- Fulfillment of accounting and tax obligations;
- Fraud prevention and website security;
- Analytics, reporting, and development of the “Dreams Without Borders” project.

4. Legal Basis for Processing

- **Consent** of the parent/legal guardian — Art. 6(1)(a), Art. 8 GDPR.
- **Contract performance** (contest participation, donation processing) — Art. 6(1)(b) GDPR.
- **Legitimate interest** — ensuring security, fraud prevention, service improvement — Art. 6(1)(f) GDPR.
- **Legal obligation** — accounting and tax compliance — Art. 6(1)(c) GDPR.

5. Data Transfer and Storage

5.1. All personal data is stored on secure servers located within the **European Union (Germany/France)** and is not transferred outside the EU without appropriate safeguards (SCC).

5.2. Data may be shared with third parties **only in full compliance with GDPR**, including:

- Technical service providers (IT, hosting, anti-fraud);
 - Payment operators (Stripe Payments Europe Ltd);
 - Logistics partners (delivery of capsules and prizes);
 - Public authorities — only when legally required.
- 5.3. All partners and contractors sign a **Data Processing Agreement (DPA)**.

6. Donations and Payment Information

6.1. Users may voluntarily make a donation to support the “Dreams Without Borders” campaign and project.

6.2. All payments are processed via **Stripe Payments Europe Ltd**, registered in Ireland and fully compliant with GDPR.

6.3. We receive only general payment information (name, e-mail, amount, country, date).

Financial credentials (card number, CVV, etc.) are transmitted directly to Stripe and are not stored on our servers.

6.4. The funds are used to support events, manufacture and distribution of capsules, and development of the cultural and educational project “Dreams Without Borders.”

6.5. Donor and transaction data is stored for up to **5 years** in accordance with Cypriot accounting and tax laws.

6.6. By completing a payment, the User automatically agrees to this Policy and **Stripe’s Privacy Policy** (<https://stripe.com/privacy>).

7. Cookies and Analytics

We use cookies for the following purposes:

- Proper operation of the website and registration forms;
- Fraud prevention during voting;
- Traffic analysis and functionality improvement.

You can disable cookies in your browser settings; however, this may limit some site features.

8. Data Retention Periods

Data Category	Retention Period
Participant registration data	Up to 6 months after contest completion
Winners’ works (name, city, video)	Up to 3 years
Voting technical logs	Up to 12 months
Donor and transaction data	Up to 5 years

Data Category	Retention Period
Capsule storage data	Up to 25 years (under a separate agreement)

9. Rights of Parents and Users

Parents or users have the right to:

- Request access to their data;
- Request correction or deletion of data;
- Restrict processing;
- Withdraw consent;
- Lodge a complaint with their national Data Protection Authority (DPA).

10. Data Protection Measures

We apply a comprehensive set of technical and organizational measures, including:

- Data encryption (SSL/TLS, AES-256);
- Role-based access control;
- Regular backups;
- Security audits and access logging.

11. International Data Transfers

Transfers of personal data outside the EU are permitted only under adequate legal safeguards — **Standard Contractual Clauses (SCC)** or **adequacy decisions** under Articles 45–46 GDPR.

12. Amendments to the Policy
